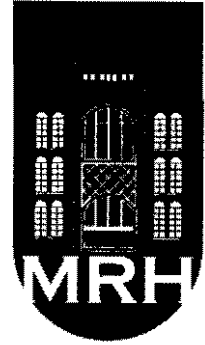

**Information and Consent Form  
University of Missouri—St. Louis**
