ELECTRONIC RESOURCES

Lexis/NexisTM Academic:

It is possible to access state high court & appellate decisions, statutory laws and court rules from Missouri (and other states), and Attorneys General opinions from Missouri (and other states) by using the *Lexis/NexisTM Academic* database, Legal Research segment. Basic searching is by keyword.

The Missouri Senate and House of Representatives provide a Joint Bill Tracking service which allows searching of legislation from 1995 to the present by bill number, keyword, or sponsor-cosponsor. Information includes the text of the bill, names of sponsors and cosponsors, committee(s) to which the bill was referred, and actions taken – up to and including signature by the governor for truly agreed to and finally passed versions.
