### **Dissertation Deadlines**

In order to receive the Ph.D. by the end of this semester, ABDs must be ready to submit a copy of their dissertation in "essentially final form" to the Graduate School six weeks prior to the end of the semester (i.e., by *November 1*<sup>st</sup>). Students

who plan on receiving the Ph.D. by May 2005 must have their dissertation completed by *April Ist*. Finally, students who plan on completing their degree by the end of this academic year must have completed the dissertation by *July 1st*. Remember, *you must be enrolled in the semester in which you defend your dissertation*. Also, be aware that summer graduations are much more difficult to coordinate because of faculty research obligations. **Be sure to plan ahead.**
