New CCJ Faculty

The department is happy to welcome three new tenure-track assistant professors. *Kristin Carbone-Lopez* received her Ph.D. in Sociology from the University of Minnesota in 2006. Her research considers the intersection of gender, crime and victimization, with a particular emphasis on violence between intimate partners. Kristin has a joint appointment with the Institute for Women and Gender Studies.

*Lee Ann Slocum* received her Ph.D. in Criminology and Criminal Justice from the University of Maryland in 2007. Her research focuses on intra-individual change and stability in offending and substance use over time, with a specific emphasis on understanding the role of stressors in the process. She is also interested in the study of person-environment interactions and selection processes, intergenerational patterns of antisocial behavior, and research methodology.

Andres Rengifo received his Ph.D. in Criminal Justice from the City University of New York (CUNY) Graduate Center - John Jay College in 2007. His research focuses primarily on communities and crime, emphasizing the linkages between neighborhood effects, social networks, and informal controls. Andres' current areas of interest include the study of incarceration and reentry using network simulation as well as the development of a network-based approach to measure local processes of social integration.

### **Dissertation Deadlines**

Students who plan to receive the Ph.D. by May 2008 must have their dissertation completed by *April 1<sup>st</sup>*. Remember, *you must be enrolled in the semester in which you defend your dissertation*. Also, be aware that summer graduations are much more

difficult to coordinate because of faculty research obligations. **Be sure to plan ahead.**
