# US News and World Report Ranks Doctoral Program Fourth in the Nation

The UMSL CCJ Ph.D. program was ranked #4 among Criminology and Criminal Justice Doctoral Programs in the Nation according to the 2010 *U.S. News & World Report* peer rankings. These peer rankings update earlier rankings in which UMSL was also ranked fourth, tied with the University of California-Irvine, and Rutgers State University.

## **Dissertation Deadlines**

In order to receive the Ph.D. by the end of this semester, ABDs must be ready to submit a copy of their dissertation in "essentially final form" to the Graduate School six weeks prior to the end of the semester. Students who plan to receive the Ph.D. by May 2010 must have their dissertation completed by **April 1st.** Finally, students who plan to complete their degree by the end of this academic year must have completed the dissertation by **July 1st.** Remember, *you must be enrolled in the semester in which you defend your dissertation.* Also, be aware that summer graduations are much more difficult to coordinate because of faculty research obligations. **Be sure to plan ahead.**
