Professor DiPietro was also awarded a Fulbright Fellowship to conduct research in Bosnia-Herzegovina in 2014.

Faculty Awards and Appointments

Kristin Carbone-Lopez, **Lee Slocum**, and **T.J. Taylor** received tenure and were promoted from Assistant to Associate Professor. **Tim Maher** was promoted from Associate to Full Teaching Professor.

Stephanie DiPietro was awarded a Fulbright Scholar grant for the project "A Cross National Study of Criminal Trajectories in Post-War Bosnia and St. Louis." She will spend the Spring 2014 semester researching and teaching at the University of Sarajevo in Bosnia-Herzegovina.

Stephanie DiPietro received the 2013 Gerald and Deanne Gitner Excellence in Teaching Award.

Beth Huebner was honored by her alma mater, Michigan State. She was inducted into the School of Criminal Justice Wall of Fame, which "honors alumni and faculty who have achieved the highest level of professional accomplishment while demonstrating strong personal integrity and character."

Janet Lauritsen was awarded a University of Missouri Curators' Professorship. Curators' Professorships are prestigious positions, and only outstanding scholars with established reputations are considered for appointment.

Janet Lauritsen was named a Fellow of the American Society of Criminology. The honorary title "Fellow" recognizes persons who have made a scholarly contribution to the intellectual life of the discipline.

Rick Rosenfeld received the 2013 Chancellor's Award for Excellence in Service. Dr. Rosenfeld is the only UMSL faculty member to receive all three Chancellor's Awards. He won the award for Research & Creativity in 2006 and for Teaching in 1994. This is also the fourth year in a row that our faculty have won a Chancellor's Award.

Rick Rosenfeld has been named Chairperson of the National Academy of Sciences' Roundtable on Crime Trends. Funded by the National Institute of Justice, this three-year project is designed to develop a better understanding of the factors associated with changes in crime over time, both in the U.S. and elsewhere. The Roundtable consists of twelve academics and four practitioners. **Dan Isom** and **Janet Lauritsen** are also members of the Roundtable. Dissertation Deadlines

ABDs must be ready to submit a copy of their dissertation in "essentially final form" to the Graduate School six weeks prior to the end of the semester. Students who plan to receive the PhD by May 2014 must have their dissertation completed by **April 1st**. Finally, students who plan to complete their degree by the end of this academic year must have completed the dissertation by **July 1st**. Remember, *you must be enrolled in the semester in which you defend your dissertation*. Also, be aware that summer graduations are much more difficult to coordinate because of faculty research obligations. **Be sure to plan ahead.**

ALUMNUS CHUCK HUBER GIVES A VERY GENEROUS GIFT TO CCJ

Almost 30 years ago, Charles “Chuck” Huber sat in the front row of Richard Wright’s first criminology course at UMSL. Dr. Wright became a mentor and friend to Mr. Huber, and they’ve kept in touch over the years. After receiving his BS at UMSL in Administration of Justice, Mr. Huber graduated from Washington University School of Law and eventually became President of Ralcorp Frozen Bakery Products. This spring, Mr. Huber gave the Department of Criminology and Criminal Justice \$100,000 in Ralcorp stock. The gift will be used to create the Charles G.
