While the students loved the entire experience, most were especially enthusiastic about the opportunity to observe the trial of Dominic Ongwen at the International Criminal Court in The Hague. 

OBITUARY - ROBERT J. BURSIK, JR.

We begin this academic year with sad news: one of our most popular teachers and dear colleague, Professor Robert "Bob" J. Bursik, Jr., passed away on July 19, 2017 just one year after his retirement. In addition to being an excellent teacher, regaling students with his humor and wit. Bob was an accomplished scholar and is widely recognized as one of the key persons responsible for the resurgence of community studies of crime in the late 1980s. His book Neighborhoods and Crime: The Dimensions of Effective Community Control, co-authored with Harold G. Grasmick (1993), Lexington Books, identified many of the important elements necessary for a comprehensive understanding of how community organization, through its formal and informal networks, could work to control levels of crime and delinquency. His other areas of research included crime and immigration, contextual analysis, changes in urban areas and crime over time, and broader tests of core crimi-



nological hypotheses. Bob served as Editor of the discipline's flagship journal *Criminology* from 1997 to 2003, and was named Fellow of the American Society of Criminology (ASC) in 1998.
