# **Special Projects and Events**

# **UM-St. Louis Tsunami Reconstruction Project**

Jody Miller is Coordinator of the UM-St. Louis Tsunami Reconstruction Project. Established after the Asian Tsunami of December 2004 in partnership with the Sri Lanka Library Association, the project targets two tsunamiaffected schools in Sri Lanka. The first, Thambilivul Maha Vidyalaya, is a secondary school on Sri Lanka's east coast. The second, Andaragasyaya Vidyalaya, is a primary school on the south coast. Jody attended Andaragasyaya's official library opening in January 2006, and spoke as the representative for UM-St. Louis.

In addition to rebuilding and renovating the school libraries, the project is designed to provide sustained educational programming for students, teachers and parents. Art and music workshops have been held for the students, and the school librarians are being funded to attend a one-year library sciences training course. The project is currently seeking funds for (1) a parent's workshop, and (2) a field trip for fourth and fifth graders to Sri Lanka's capital city of Colombo. In addition, in January 2006 we are kicking off a "sponsor a student" campaign, in which members of the UMSL community can sponsor an Andaragasyaya student. Proceeds provide school supplies for the children. Finally, students who plan to complete their degree by the end of this academic year must have completed the dissertation by *July 1st*. Remember, *you must be enrolled in the semester in which you defend your dissertation*. Also, be aware that summer graduations are much more difficult to coordinate because of faculty research obligations. **Be sure to plan ahead.**
