# Minutes of the Meeting of the University of Missouri-St. Louis Faculty Senate February 20, 2018 202 JCPenney

The Faculty Senate meeting was called to order at 4:30 p.m. following the University Assembly meeting. Dr. Stuerke asked for approval of the Senate minutes from the meeting on Jan. 23, 2018. The minutes were approved as written.

Chancellor George did not have any additional information to report.

### Report of the Spring Research Panel, Dr. Stephen Holmes:

Dr. Holmes reported that the members of the Spring Research Panel recommend that the eligibility for the Chancellor's Award for Research and Creativity be changed as follows:

## Currently reads:

Purpose: The purpose of this annual award is to honor a full-time, regular faculty member who has demonstrated superior achievement in a program of research and creativity.

#### Proposed change (in red) to read:

Purpose: The purpose of this annual award is to honor a full-time, regular faculty member who has demonstrated superior achievement in a program of research and creativity.

Dr. Holmes explained that this change will allow non-tenure track faculty to be included in the eligibility for this award.

## The Faculty Senate voted on the proposed change. All were in favor of the change.

Dr. Holmes also reported the following from the Spring Research Panel:

- ➤ March 1 Nominations due for Chancellor's Award for Research and Creativity
- ➤ March 12 UMSL Research Award Proposal due

  Dr. Holmes explained that the UMSL research award is designed to strengthen faculty research and creative activities. A significant portion of the funds available for faculty research support is based on F&A cost recovery from externally funded grants and contracts. In order to perpetuate the fund, one goal of the UMSL Research Awards is to support faculty whose competitive position for external funding will be improved by such assistance. Awards are also given to help faculty in all disciplines maintain an active research program, even if external funding is difficult to obtain. Awards are intended to promote research innovation and the long-term success of an applicant's program rather than as a vehicle for student support. Special consideration, particularly for summer research support, is given to junior faculty to assist them in establishing a strong research record. The amount of the UMSL Research award ranges from \$1,000 − \$12,500
