

The Master of Accounting degree is intended for students preparing to enter the CPA profession or practicing professionals seeking to become CPAs or CMAs or otherwise advance their careers. The Master of Accounting degree usually requires 30 hours for a candidate with an undergraduate degree in accounting. Candidates with an undergraduate degree in business will usually require 36 credit hours to complete the program. Candidates with a non-business undergraduate degree will usually require 42 credit hours to complete the program.

### Career Outlook

Accounting and the CPA Profession remain crucial to efficiently and effectively operating capital markets. Thus, plentiful career opportunities have remained available to UMSL Accounting graduates in strong and lesser strong economic times. UMSL Accounting graduates typically start their careers at either the audit or tax departments at CPA firms or corporations.
