You are asked to demonstrate your clinical counseling skills by uploading a 20-minute role play of a counseling session with a mock-client ages 5-18 years old. This video recording must NOT be of a real client or your child. The mock-client selected for this role play should NOT be exhibiting severe behavioral or emotional problems at this time. The video must be accompanied by a signed release by the child's parent or guardian and the child participating in the session if applicable. The video will be reviewed for evidence of basic counseling microskills (e.g., empathic nonverbals, paraphrasing, reflections of feeling, focusing, summarization). If skill deficiencies are noted and you are admitted, you may be required to complete UMSL's *Helping Relationship Skills* course.

Post the video in an online format to include on this application. We recommend you add the video to your Google Drive and share the file with anyone with the link or post on YouTube as an UNLISTED link.
