\*Modified Total Direct Costs (MTDC) are total direct cost minus

- All capital expenditures (buildings, significant renovations, etc.)
- Individual items of equipment with a single unit value of \$10,000 or greater, and an estimated useful life of more than one year
- That portion of each individual sub-award (subcontract) in excess of \$50,000, whether the services are obtained from an owned, related, or third-party hospital or other medical facility
- All rental/maintenance of off-site activities (space)
- All student support costs (e.g., tuition remission, scholarships, fellowships)
- Participant support costs

\*\*On Campus vs. Off Campus rates

Activities conducted in facilities not owned by the University of Missouri–St. Louis are considered off- campus.
