16	Tuesday	Eight Week One classes begin 8:00 a.m.
19	Friday	Last day any student may enroll (enter a course for credit) in an Eight Week One course. Last day Registrar’s Office will move students automatically from the waitlist to open sections.
29	Monday	Last day to drop an Eight Week One course without receiving a grade. Last day a student may place an Eight Week One course on Satisfactory/Unsatisfactory basis.
30	Tuesday	First day all Eight Week One dropped courses and withdrawals from term are assigned an EX grade.
FEBRUARY		
12	Monday	Last day to drop a course or withdraw from an Eight Week One course without instructor approval. EX grade will be assigned.
13	Tuesday	First day all Eight Week One dropped courses require instructor approval. EX or EX-F grade will be assigned.
26	Monday	Last day to drop or withdraw from an Eight Week One course. Instructor approval is required. A grade of EX or EX-F will be assigned.
27	Tuesday	As of this date students with exigent circumstances that need to drop an Eight Week One class or withdraw from the term must provide documentation of exigent circumstances and receive approval from both the instructor and the dean. If approved, grades of EX or EX-F will be assigned.

01	Monday	Classes resume 8:00am Last day to drop an Eight Week Two course without receiving a grade. Last day a student may place an Eight Week Two course on Satisfactory/Unsatisfactory basis.
02	Tuesday	First day all Eight Week Two dropped courses and withdrawals are assigned an EX grade.
15	Monday	Last day to drop or withdraw from an Eight Week Two session without instructor approval. EX grade will be assigned.
16	Tuesday	First day all Eight Week Two dropped courses require instructor approval. EX or EX-F grade will be assigned.
29	Monday	Last day to drop or withdraw from an Eight Week Two course. Instructor approval is required. EX or EX-F grade will be assigned.
