President David Garin reported that the RA newsletter is now being distributed via email to reduce expenses for the RA. He requested members to please provide an email address at which to receive the newsletter. He gave special thanks to board member Sharon Davis for assembling and producing the newsletter. Garin summarized some of the issues brought up at a meeting of campus RAs which was attended by the new system president, Tim Wolfe. RA representatives were alerted to the need to generate support for the Nov. ballot proposition to raise the state tax on tobacco. The tax goes only to education. [Update: Proposition failed]. Garin announced that the UM Press is being phased out but some publications will appear on the UM Press Facebook page.

Garin called upon Secretary Steven Spaner to present the Minutes from the last business meeting of the UMSL-RA, December 6, 2011. Spaner asked for corrections and additions to the distributed minutes. None were offered. Garin declared the minutes accepted as distributed.

Next Garin recognized Treasurer Rick Blanton to presented his report (see attached). Garin asked for a motion to accept the treasurer's report. <u>Motion to accept was offered and passed.</u>

Finally Garin recognized Past President Shirley Martin to present the slate of nominees for the two open RA officer positions and the three open RA board positions. This year the president and vice-president officer positions were to be elected. Martin, as nominating committee chair, presented the committee's slate of David Garin for president, David Ganz for vice-president.
