#### Minutes

The minutes from the April 21, 2017 meeting were accepted. It was clarified that Hal Harris as chair of the membership committee will lead the newly established task force. #### Agenda for Association Meeting

An agenda for today's association meeting today was discussed. The December 13, 2016 minutes were accepted and will be reviewed by the full association. An announcement will be made that the tour of the new Business building today is cancelled. The building is not ready for touring. The grand opening will be sometime in August.

#### Activities to be announced

A fall foliage and wine tour will be held either in late September or early October. The group thought it would be easier to have participants drive themselves to a meeting location, possibly carpool and then proceed with the tour.

A presentation by Blanche Touhill on the history of the campus is another proposed activity. The lecture, which was presented to the 1967 graduates at their 50<sup>th</sup> reunion in May focuses on the very early history. Indeed Dr. Touhill had volunteered to give the presentation to the RA. The event should be campus wide, include retirees and current faculty, and might be held in the new Business building. A reception should follow.

Zuleyma suggested a visit to the Missouri History Museum to see the Civil Rights Movement and ask Gwen Moore to give a tour to the group. Chuck Korr added that the Route 66 exhibit is also very good and has enjoyed record attendance.

#### **UMRA Meeting**

The benefits committee is again looking at the suggestion to offer a COLA to those who retired before 1990.

President Choi talked tough at the meeting. On the other hand it looks like our campus budget cuts are in line with our funding level.

All campuses seem to have the same problem with getting an accurate list of retirees.
