News from the UMSL RA Board meeting, October 11, 2013

Board members discussed the upcoming holiday lunch at Glen Echo Country Club on Dec 6. Last year, the price was \$20 and the lunch was subsidized. Issues included whether the lunch should be subsidized and the quantity of food served. Our two major expenses are the holiday lunch, including the cost of invitations, and producing and mailing the newsletter. A final determination on menu and costs was not reached but those details will be included in your invitation, coming soon.

Garin briefly discussed the issue of nonprofit status. Twenty-five years ago we applied to the Internal Revenue Service for an Employer Identification Number (EIN). We received an EIN and were informed that it did not grant tax-exempt status. However, if our normal annual gross receipts were not more than \$5,000, and if we met the requirements of section 501(c)(3) of the IRS code, we were not required to file annual forms. If we become tax-exempt, donations are tax deductible but subsidies are not permitted. (Subsequently, we learned that the rules have changed and we will probably have to file annually with both the state and the federal government.)

In a written notice, Steve Spaner raised the need for someone to be responsible for membership services. The treasurer handles the financial aspects of membership and the vice president is responsible for membership recruitment. But who is responsible for non-financial aspects of membership maintenance of a current membership directory, communication with members (e.g., newsletters) and events for members? Spaner made a written motion that we amend the constitution to change the duties of the vice president to include membership services. A lengthy debated ensued. Davis, who as treasurer assumed some of these responsibilities in the past, suggested that the treasurer already has a spread sheet with additional information including mailing and emailing addresses, making it logical for the treasurer to assume some of these duties. Davis also suggested that activities and services should be handled by others on the board or in the general membership. If the membership addresses are needed for a mailing, a copy of the spread sheet file can be provided. Following discussion, Martin made a motion to table. That motion was passed 5-1.

Several board members suggested that we need to initiate more events. Barton recommended a committee to deal with activities. Garin suggested that with additional email newsletters to members, it is possible to initiate events in a timelier manner than in the past. The UM system plans to send four emails a year to retirees and will include campus specific information. Davis

provided a memo earlier this year that stated we have email addresses for 188 of our 225 UMSL members. However, a high percentage of these addresses are not current. Ganz asked if the UM system will share email addresses with us. Davis said, at the least, we need to know who has email and who doesn't.

A motion to amend the constitution, written by Steve Spaner, was presented. It deals with term limits for officer positions. UMSL allows longer terms for officers than the other three UM campus retiree organizations. The purpose of the amendment is to get more members involved, inject new blood and ideas, and share the workload. Spaner suggested a maximum of three terms, which would total six years. The motion passed unanimously. Garin will include the amendment in the fall newsletter so that the issue can be presented to the membership at the holiday luncheon.

Proposed Amendment to the Constitution

According to Article VIII of our constitution, "the constitution may be amended by a majority of those regular members attending a duly called meeting, provided all regular members have been notified of the proposed amendment at least 21 days in advance". This publication constitutes such notification.

Constitutional amendment (changes from the current article are in bold italics):

Article V – Officers

There will be four officers of the association as described below. Each officer must be a regular member of the Association. Each officer serves a two-year term and may be reelected at the pleasure of the membership *to a total of three terms*. Terms should be staggered so that two officers are elected each year.

Report from the UM Retirees Associations meeting with UM President Tim Wolfe, Columbia, MO; Oct. 16, 2013

UMSL was represented at the meeting by Sharon Davis, Dave Ganz, David Garin and Fred Wilke.

The UM system is reviewing the entire benefits program. This Total Rewards Program has an ad hoc task force, which meets twice a month. The task force includes a retirees' representative, Rose Porter (UMC), who reported that the Board of Curators is split on the issue of all benefits. President Wolfe has stated that the pension plan is "untouchable". It is currently at 85% of actuarial funding. Health benefits are a big issue. The long-term liability for all retiree medical is \$500M.

Questions included whether changes in medical will affect only new retirees. Ken Hutchinson, former VP for human resources, wondered if the university will subsidize retirees going onto the Affordable Care Act (ACA) exchange. Porter thinks we will do better with the new ACA than with Coventry.

The curators want recommendations from the ad hoc task force for their April meeting. The Total Rewards Program task force will send their recommendations to the UM System Retirement, Salary and Benefits Committee, then to the UM President who will make his case to the Board of Curators.

Updates from the different campus retirees associations:

Columbia—retirees gave a \$6M gift to UM; tax issues were resolved and a 501(c)(4) for MURA was obtained, resulting in sales tax exemption and non-profit mail rates.

Kansas City—celebrating its 80th anniversary; the Emeritus College has a dean and will open in March, using space in the UMKC library.

Rolla—sends one newsletter/yr; annual work with United Way campaign, Chancellor pays for one membership directory every two years; will have a 2 yr term for president which is actually 6 years (two years each as vice-president., president, past president); luncheons are \$11 and draw 80-90 members.

St. Louis—Jubilee year; holiday lunch in December; possible term limits via a proposed constitutional amendment; reviewing legal standing as a non-profit.

We received an E-newsletter program update from Melanie Barger, manager of constituency communications, UM system. In order to obtain email addresses of retirees, she sent letters to 8500 people and now has 8445 email addresses. She will be able to update the email addresses. The E-newsletter will be called UM Connection and be in html format. It will be sent quarterly to all retirees for whom Barger has an email address, starting in January 2014. There will be a separate section that is campus specific. The campus specific section can include events, announcements, membership information, personal milestones, etc.

UM President Tim Wolfe described ongoing executive searches and his Show Me Value campaign pointed toward rural Missouri, since they have not supported educational initiatives. In a question and answer period that followed, Garin asked if there was a commitment to the retirees health benefit. Wolfe said it was up to the benefits committee. Garin then emphasized the importance of that benefit to many retirees since the dollar value was independent of prior salary and thus of

prime importance to many lower paid employees. Separately, Ken Hutchinson commented that he was relatively certain that the university would continue to provide some support for health care premiums and that retirees may do better with the ACA exchange than with Coventry.

Renetta Gallup, Director of Pension and Deferred Compensation, gave a power point presentation regarding health care costs for 2014. The enrollment period for retirees is November 4-15, 2013. See www.myhr.umsystem.edu for your personal information, making address changes, etc. Changes are effective 1/1/14. Costs and changes are available on line. Premium increases range from 0-3% depending upon choice of plans. There is no increase in dental but a 2% increase in vision.

IRS rules require a change in the way retirees who return to work at UM are treated. There is no change for retirees aged 62 and older. Retired individuals who return to work at UM must limit their hours to less than 75% FTE. Retirees younger than age 62 who return to work at UM must have had no understanding of rehire prior to retirement and there must be a minimum of a 90 day break in service.
