# **Campus Updates**

Following the 2020 Spring Break, UMSL moved all of its instruction online to complete the spring semester and continued exclusive online offerings through the summer semester. Beginning July 1, the campus began a 3-phase reopening schedule, gradually bringing staff, faculty, and students back to campus.

While the campus is not closed to outsiders, including retirees, the general public is not encouraged to come to campus unless for official business that cannot be conducted via technology.

Those on campus are asked to monitor their health, including daily temperature screenings, and are required to wear masks in all University buildings, and anywhere on University property where social distancing cannot be guaranteed.

Public/community events, including performances at the Touhill Performing Arts Center are canceled through the rest of 2020.



Chancellor Sobolik delivered a virtual State of the University Address on September 10, 2020.

Chancellor Kirstin Sobolik gave the annual State of the University Address on September 10.

Classes began on August 24, with 60% being offered online. All courses with an enrollment greater than 30 are required to be

online. Less than 40% of courses are being offered in a "blended" format, in which students meet roughly 50% of the time in person, and 50% online. This has greatly reduced the number of students and faculty on campus at any given time. As an example, in the Fall 2019 semester, there were about 2,500 students on campus on Monday mornings. This Fall 2020 semester, there are about 400 students on campus on Monday mornings, with peak student attendance of 660-975 on Monday afternoons.

Enrollments continue to be a concern. While enrollments were up nearly 6% in the summer semester, UMSL experienced a 2.5% drop in enrollments during the fall semester. The campus has engaged a professional recruitment and enrollment management consulting firm to lend direction on stabilizing enrollments.

Due to a \$7.5 million state reallocation late in the last fiscal year, UMSL has instituted a payroll reduction plan for employees. Those making less than \$50,000 year see no reduction in salary; those making \$50,000 to \$74,999 see a 2.5% reduction; those making \$75,000 to \$99,999 see a 5% reduction; those making \$100,000 to \$124,999 are seeing a 7.5% reduction; those making over \$125,000 are seeing a 10% reduction of salary. This plan is being reviewed quarterly but has been extended at least through the second quarter ending December 31.

#### L. Sandy MacLean

In his 20 years since retirement, Dr. MacLean has been the epitome of an actively engaged retiree. He served as an Officer and Board Member of the UMSL Retirees Association from 2003-2008 and a President from 2014-2016. He was also directly involved in raising funds for scholarships for the campus.

Apart from campus, Sandy became involved with Rotary International. As a member of Rotary, Sandy has contributed as a Paul Harris Fellow

to funding a host of public service projects, e.g., study abroad and polio immunizations, and actively participated in political efforts to improve Cla1.ton. In 2012 he chaired the Clayton Committee to Pass the Bond Issue for Purchase of the New Police Station; taxpayers approved the proposal with 67% of the vote. In 2019 he chaired the Clayton Committee to Pass Proposition P, a measure that sought to increase the sales tax for the purpose of raising the salaries and benefits of St. Louis County Police. This proposition also passed easily.

Sandy has served as an example of maintaining physically fit in retirement. In 2016, he won the Missouri Games 5K meter race in his age group (80-84). In 2017, he won the race again in his age group (85-89). In each event, he won "All American Honors."

In 2018, he was president of the Pachyderm Foundation, an organization that offers financial assistance for needy students to attend their state's Boys Club or Girls Club conventions.

Whether through promoting scholarships on campus, mentoring new faculty and staff, advocating for student-interests, or community engagement like Rotary, senior athletics, or raising funds for worthwhile community causes, L. Sandy MacLean is, as one endorser labeled him, "Ambassador of the Institution."

Recreation Services in St. Charles. This is an organization that serves adults with developmental disabilities. Adult Rec Services provides social opportunities for these people. As a volunteer, Debbie helps supervise a small group as chaperone when out for events and tours.

Finally, Debbie joined the UMSL Retirees Association in 2006 and was quickly involved in RA activities, including assisting the Treasurer and preparing the membership directory in 2007. After serving the Association in various committee and administrative roles, Debbie was elected president in 2018.

Since her retirement in 2005, Debbie has consistently served the campus and the community in leadership positions, through the Botanical Garden, the Community Living Adult Recreation Services, and the UMSL Retirees Association.

# From Socializing to Protesting

### Retirees Use Cars to Get Out and Be Seen and Heard

The 2020 pandemic has momentarily redefined how we visit loved ones, celebrate milestones, and even protest causes. Many are using cars, parades, and caravans to accomplish these ends.

On May 8, 2020, RA President Clark Hickman and former board member Wendell Smith participated in a parade that included many classic cars for the Laclede Groves Retirement Community in Webster Groves. The purpose of the parade was to provide a diversion to the boredom many of those who are living in retirement communities are facing because the communities are locked down to families and visitors.

# From Socializing to Protesting (Cont.)

Organizers expected about 50 cars, but over 75 showed up for a parade that lasted nearly an hour through the Laclede Groves campus. Staff masked-up and assisted residents to the curb and stayed with them to ensure social distancing and safety. Wendell Smith drove his 1925 Rolls Royce Silver Ghost, one of 75 such cars made, and the only one known to still exist. Clark Hickman drove his restored 1996 Rolls Royce Silver Spur.

pandemic, when marching is not a safe option.

Zuleyma helped organize a "Car Caravan for Racial Justice", sponsored by MOmentum: Missouri Moving Forward, a social justice group formed in December 2016. Zuleyma said that the impetus for the car caravan was that many people were unable to participate in the ongoing marches for racial justice and Black Lives Matter because of being at higher risk for Covid due to age and/or pre-existing medical conditions.

The caravan offered these individuals an opportunity to express their solidarity and support for the movement – with the mottoes: "We Can't March, But We Can Drive!" and "Drive Out Racism – Drive In Justice".

Zuleyma said that originally only 30 to 50 cars were expected to participate, but 200 showed up for the start of the caravan! The cars, honking and displaying creative slogans and signs, made their way through a pre-determined route within University City.


