## President's Message

Second, your Executive Board has been actively engaged with counterparts among the three other campuses and the System to discuss a wide range of issues. Foremost among those was to successfully stop taking away retirees' UMSL email addresses. We are also engaging System administrators on effective ways to communicate with retirees and prospective retirees across all the campuses. These conversations are leading to fruitful and creative ways to make sure those employees facing retirement know all of their options and know how to engage in their respective campus's Retirees Association.

Third, I am proud of the excellent program on Elder Financial Abuse that our Program Committee put on in January. This two-hour webinar focused on common schemes hackers and criminals use in attempted fraud and ways to prevent it. It also focused on ways family members and other caregivers can help protect loved ones from being victims. An article about this program is included in this newsletter.

Fourth, I want to encourage you to think about potential nominees for our Annual Retirees of the Year Award. An Award is given each year to a desiring faculty and staff retiree and each receives a \$1,000 cash award. I am including an application form with this Newsletter. 
## Winter Webinar on Elder Abuse

On the afternoon of Thursday, January 28, 2021, the UMSL Retiree Association held an event titled "Elder Abuse and Exploitation– And What You Can Do About It". Because of the Covid pandemic the event was on Zoom. The panel, consisting of three speakers, was sponsored by the St. Louis County Older Adult Commission (StLC- OAC).

Panelists presented information on various aspects of the topic followed by a question and answer period.

Carroll Rodriguez, Vice-chair of the StLC-OAC, and formerly the Senior VP of Governmental Affairs and Advocacy of the Alzheimer's Association in St. Louis, gave an overview of the extent of the problem and the various forms of abuse and exploitation experienced by older adults – not only in Missouri but also on a national level.

Mary Tucker (member of the St. Louis Elder Financial Protection Multidisciplinary Team and former Director of Elder Clients Initiative Team at Wells Fargo Advisors) presented an in depth discussion of the types of financial abuse, as well as real-life examples of exploitation perpetrated by family members, caretakers, and strangers.



The final segment, presented by renowned elder law and disability attorney Debra Schuster (from the law firm of Paule, Camazine and Blumenthal), covered the legal remedies and resources available to older adults who experience abuse and exploitation. UMSL Retiree Association board member and panel organizer, Zuleyma Tang-Martinez (also a member of the StLC-OAC) moderated the discussion.

Almost 30 individuals attended the event, which seemed to be very well received. During the question and answer session, as well as afterwards, several participants commented on the usefulness of the information and on the new insights they had gained as a result of listening to the presentations.





## 2021 Chancellor's Retiree of the Year Awards Nomination Form

The Chancellor's Retiree of the Year Awards focus on the accomplishments of former UMSL employees, after their retirement. These accomplishments may involve volunteer service to the University, civic and welfare services, career and professional activities, or other noteworthy accomplishments. Accomplishments prior to retirement are not considered in the selection process.

Two awards will be given: one to a faculty member and one to a staff member. Each award includes a plaque and a check.

### Criteria for Candidates

- Nominees must have retired from UMSL before January 1, 2016.
- Recipients are expected to attend the annual Chancellor's State of the University Address to receive the award.
- Nominees must be fully retired from UMSL and not in any paid University position since January 1, 2016.

### Nomination Process

To nominate (or re-nominate) a retiree, please complete the form below and:

1. Prepare a letter with the following information:
  - a. Nominee's extraordinary accomplishments since retiring.
  - b. Personal and background information about the nominee.
  - c. Summary—most important reason(s) why you believe the candidate should receive one of the awards.
2. Attach two (2) letters of support from others who know the nominee.
3. Please keep the nomination package to 10 pages or less, excluding this cover Nomination Form.
4. It is possible to nominate one's self.
