## **Behavioral Health Workforce Education and Training (BHWET II) Program Application**

BHWET II is a federally funded project designed to prepare MSW students for the unique demands of at-risk individuals of any age, who have unmet behavioral health needs and particularly those living in rural and medically underserved areas.

Applications will be accepted for students beginning specialization practicum in the fall, spring, and/or summer. This award includes:

- \$10,000 stipend for two semester 600 hour commitment
- Specialized training in integrated behavioral health
- Opportunities for professional networking
- A career services network

### **Requirements**

- Practicum setting must include the behavioral health of at-risk populations
- Commitment to participating in training (i.e., bi-weekly seminars, annual BHWET conferences, other activities as scheduled) and networking activities
- Full specialization practicum (6800 & 6850) commitment with a minimum of 20 dedicated hours/week within the agency for interdisciplinary training opportunities
- Agreement with and signature on the commitment letter
