She was offered a very nice position with the St. Louis Fed Bank and she couldn't turn it down. I am, however, pleased to report that Barb Flowers, another alum, has taken over as Director. The Center is in good hands with Barb at the helm. Also related to the Center is another piece of good news. Sharon Laux has been loosely associated with the center and the department for some time, but now she is officially employed by the Center.

The final piece of news is that Lea Kosnik won the Gitner Teaching Award. The award was presented at the Chancellor's State of the University Address. Many thanks to Anne Winkler for putting together

the nomination.

Faculty Notes

Tom Ireland published two papers, "Historical Net Discount Rates – An Update Through 2005" in *The Earnings Analyst*, 2006, and "Economic Damages under House Bill 393" (with David Tucek, UM-St. Louis M. A. 1976) in the *Journal of the Missouri Bar*, July-August, 2006. Tom also appeared on a number of professional programs, including making a presentation on "Hedonic Damages as Junk Science" to the Damages Seminar of the Defense Research Institute in March 2007.

Lea-Rachel Kosnik received the Gerald and Deanne Gitner Excellence in Teaching Award this past September – thank you to all her students, past and present, who contributed to this teaching success! Professor Kosnik also traveled to China in November on a combined UMSL/Chinese Academy of Social Sciences Academic Fellowship. Professor Kosnik's latest research results were presented at the AEAs in Chicago (on a Small Grants Research Award), and at the International Industrial Organization Conference in Boston. Perhaps most noteworthy of all, Professor Kosnik took the big plunge this past December and got married. We'll let you know the relative success of that decision in the 2008 newsletter....

William H Rogers His work is focused on the impact of homeowner associations in the housing markets and municipal zoning and also the effects private schools on income segregation in the housing market. This summer William, with the excellent assistance of economics graduate students Juan Fung and Christian Falde, collected primary data detailing the covenant and amenity characteristics of homeowners associations in western Saint Louis County. He also presented "Are Homeowner Associations Complements or Substitutes to Municipal Zoning?" at the 53rd Annual Meetings of the Regional Science Association International in Toronto, Canada. William has also assumed the role of faculty advisor to the economics clubs, a position previously held by Don Kridel.

Dave Rose continues to serve as the department's chairperson. After an absence of a few years he is again teaching Economics 5001: *Graduate Microeconomic Theory*. Many alumni no doubt have fond memories of this course. He has two papers out circulating, a fairly technical piece titled "The Dynamics of Small Industries," with S. Braguinsky, S. Gabdrakhmanov, and A. Ohyama (this has been submitted to the *Journal of Development Economics*), and a more traditional

solo-authored theory piece titled "Competition, Cooperation, and the Neighboring Farmer Effect," (this has been submitted to the *Journal of Economic Behavior and Organization*). His main professional pre-occupation, however, is his book, *The Moral Foundation of Economic Behavior*, which is nearing completion. Many of you may remember Dave's two boys from department picnics. Matt is now at Mizzou majoring in Economics and History, while Chris is now in high school where his main interests are science and playing violin in the high school orchestra.

Anne Winkler has a paper on teen employment forthcoming in *Monthly Labor Review* and presented another paper on time spent in household management (co-authored with Tom Ireland) at the Allied Social Science Association (ASSA) meetings. Both these projects utilize newly available data from the American Time Use Survey. In January 2007, Anne, Sharon Levin, and Paula Stephan (Georgia State) began work on their project titled "The Diffusion of Information Technology across Institutions of Higher Education: Effects on Productivity by Type of Institution and Gender." This research is funded by a grant from the Mellon Foundation. In the summer months, you can find Anne playing in the U-City Summer Band.

Debra Garcia continues to serve, as she has for the last four years, as the administrative associate of the department. During these four years she has witnessed the first group of students (the Michael Thomas, Ken Brockland, Lauren Fitterman group, who started the program at the inception of her reign) graduate and move forward with their life endeavors.
