- Bruce Welz established (and fully funded) a new scholarship honoring Robert Loring Allen (see Page 3). The first award was made this spring. Harry Heyburn, an UMSL scholar-athlete (tennis) was the first recipient.
- In alumni news, Marcela Manjarrez-Williams left the St. Louis Federal Reserve Bank and is now Senior Vice President and Chief Communications Officer at Centene. For more on the outstanding success of our alumni, see Pages 4-5.
- Following the elimination of Continuing Education on the UMSL campus, the Center for Entrepreneurship and Economic Education, headed by **Grant Black** (BS 1992, MA 1993), has "re-joined" the Department. We believe this should provide for even more synergy between the Center and the Department and look forward to new opportunities.

The Applied Econometrics and Data Analysis Certificate that we announced in summer 2013 has exceeded our expectations. As of this summer, we have already had nine Certificates awarded—including one student who came back after graduation to finish the

certificate. **Melissa Maxwell** (MA 2015) was the first Department recipient of the Graduate Policy and Program Evaluation Certificate (joint with MPPA). There are currently 12 dual-degree BS/MA ("2+3") students, our largest-ever cohort.

We were pleased to have an opportunity to reconnect with two far-flung alumni. Victor Potopov traveled from Toronto to attend this year's Alumni Party. (He received an unofficial award for "greatest distance travelled.") Muneer Al-Maskery (Distinguished UMSL Alum), from Oman, visited with Department members on a recent trip to St. Louis to meet with Joel Glassman and others in the Center for International Studies.

We are fortunate to have additional intellectual capital in the department: Carl-Magnus Bjuggren and Tamas Csabafi. Carl is a Post Doctoral Research Fellow from the Research Institute of Industrial Economics in Stockholm, Sweden. Tamas is a Post Doc working with Max Gillman; Tamas comes to us via Central **European University** (Budapest, Hungary) and Cardiff University (Cardiff, UK). Both Carl and Tamas increase our international profile (and make the Departmental average age significantly lower!).

Emilio Pagoulatos, former faculty member, has made a generous donation to start a Robert Sorensen Endowed Scholarship. We will be looking for additional donations in the coming months to help fund this scholarship. (See last year's Newsletter for a reminder of Bob's importance to the development and profile of the Department.)

Please join us—even if you have never done so before— at the **Fall Picnic** on Sunday, September 20th, and at the **Alumni Party** next spring on April 15th.



Remembering Professor Don Phares



Don Phares, scholar, researcher, teacher, urbanist, university administrator, sports fan, father, friend, and colleague died peacefully at his home in St. Louis, MO, on June 27, 2015.

Don received his BA in Economics from Northeastern University and both an MA and PhD in Economics from Syracuse University. He joined the UMSL Department of Economics in 1969 and served the department for over 30 years. While he formally retired in 2003, he continued his association with UMSL on a part-time basis and remained research active long into retirement.

Don was instrumental in the early development of the department. He provided important input into the hiring of new research faculty, the development of the Master's program, and the introduction of the Bachelor of Science degree.

Along with the standard micro and macro courses, Don's teaching focused on Urban Economics and State and Local Public Finance, which he taught at both the graduate and undergraduate level. He inspired many students, some of whom went on to obtain PhD degrees in Urban

Economics and Public Finance, and many others who took positions as policy analysts in government.

Former student, Jerry Evensky (MA 1979), Professor of Economics and Meredith Professor for Teaching Excellence at Syracuse University, shared the following remembrance: "Don was instrumental - by his warm, thoughtful, nurturing and professional support - in shaping the trajectory of my career. I am eternally grateful to him and for him."

Despite the many other administrative claims on his time from various entities on campus, Don was always there when the department had a need. He served as department chair and often taught courses when he had other administrative assignments.

Don's commitment to UMSL extended well beyond our department. He held a joint faculty appointment in the Public Policy Administration Program. Further, he was a central figure in the history and development of the Public Policy Research Center (PPRC). Among his roles, he served as Director of the Center for Metropolitan Studies, one of the three unit that later became the PPRC. As emeritus professor, he continued to be involved in PPRC activities. Don also served as vice chancellor. His contributions were widely recognized and highly valued. In 1997, he received the University of Missouri Thomas Jefferson Award. This award, only one of which is made per year, is presented to faculty members who "rise above excellence and demonstrate clear distinction in teaching, research, and service to the University of Missouri and humankind."

Don was an expert urban economist, specifically focusing on the greater St. Louis area, which made him a sought after source to be quoted and interviewed by local and national media. Don served as an expert witness in legal cases pertaining to state and local taxation and economic trends. He also conducted numerous economic and fiscal impact studies for both public and private organizations. In 1987, he supervised the research staff for the state constitutionally-mandated governmental reorganization study of St. Louis City and County.

Don authored or edited six books, including "Who Pays State and Local Taxes?" and most recently in 2009, *Governing Metropolitan Regions in the Twenty-First Century.*He also wrote more than eighty articles and book chapters and scores of technical and government reports. Among his professional service activities, Don served as coeditor of *Urban Affairs Quarterly* from 1985 to 1989. He stepped down from that role when he became vice chancellor. Don was also very active in the Urban Affairs Association (UAA); in 2013, he was inducted into the UAA Service Honor Roll.

Don's contributions to the Department and the University will long be remembered. He will be greatly missed by his colleagues and former students.

Alum Bruce Welz Establishes the Robert Loring Allen Memorial Scholarship

Bruce Welz (MA 1980), who recently retired after a long career at St. Charles Community College (SCC), has generously established a scholarship in the department as a tribute to the late emeritus professor, Robert Loring Allen. Prof. Allen was on the UMSL Economics faculty from 1968 through 1987 (for details on Prof. Allen, see column on right side of this page). Prof. Allen played an influential role in Bruce's career. He taught him not only economics, but also the importance of scholarship and clarity of writing in academic pursuits.

After receiving his degree at UMSL, Bruce taught for the department for a few years and then became Associate Professor of Economics at St. Charles Community College (SCC). During his tenure at SCC, Bruce was a mentor to many economics students. Our department is thankful to Bruce not only for sending us students, but more importantly, for sending us students who would succeed and prosper. The success of Bruce's students here at UMSL reflects positively not only on his ability as a teacher, but also, on the rigor and performance standards he demanded in his classes. Bruce's contributions to our department do not end there. Most recently, Bruce played an instrumental role in the hiring of Lauren (Block) Dickens (BS/MA 2008) as Assistant Professor of Economics at SCC, continuing the long relationship between the two departments.

In recognition of Bruce's outstanding contributions to the Department over his career, Bruce received the Department's 2015 Alumni Award.

About Professor Allen

The late Robert Loring Allen was Professor Emeritus of Economics, University of Missouri-St. Louis. He was at UMSL from 1968 until 1987. His career as a professor of international economics and economic history spanned over 45 years. He was born in 1921 and served in WWII, where he was wounded. He then went on to complete a Ph.D. in economics at Harvard. He worked as an economist for the Central Intelligence Agency (1951-1956) and as a professor at the Universities of Virginia and Oregon prior to arriving at UMSL in 1968.



Robert Allen was a prolific writer and scholar. While at the CIA he authored the quintessential book on the viability of "economic warfare," with particular emphasis on the Soviet Union. While at UMSL his work focused on economic development and, in particular, on Venezuela and the role of oil and OPEC in economic development.

Center for Entrepreneurship and Economic Education (CEEE)

In July 2015 CEEE returned to its home in the Department of Economics. For many years the Center was part of the School of Professional and Continuing Studies (PCS), UMSL's Continuing Education unit. When PCS decentralized earlier in 2015, the Center gladly became a part of the Department again. Throughout its long history, the Center and Department have been intertwined. Under the leadership of then Chair Elizabeth Clayton and Prof. Joseph McKenna, efforts began in 1976 to create an Economic Education Program in the Department to expand its impact in the community and increase economic and financial literacy. In 1978 the new program launched, and Prof. McKenna was named Acting Director. In fall 1978, Prof. **William Walstad**, a new economics faculty member, was designated as the program's first Director. The University officially granted "center status" to the emerging program in 1979. Since its inception, the Center has been affiliated with the Missouri Council on Economic Education and National Council for Economic Education (now known as the Council for Economic Education—CEE).

As the Center expanded its outreach, the need for more staff grew. Elaine Coulson joined the Center in September 1979 as Curriculum Director. Sarapage

McCorkle (MA 1971) joined the staff in

1981 and later became director in 1984. David Williams (MA 1984) joined the Center as the Stock Market Game Coordinator, became Assistant Director in 1984, and remained in that post until 1991. Mary Suiter (BA 1985) began working at the Center in 1986 as Coordinator of School Services.

During 1990-91 Barb Flowers (MA 1999) joined the Center and Mary Suiter became Associate Director. Karen Hubbard, who is currently a program specialist and adjunct instructor, joined the Center in 1996. In 2004 Mary Suiter became Center Director, followed by Barb Flowers in 2006. With a wealth of expertise in consumer economics, Sharon Laux joined the Center from University of Missouri Extension in 2007. She served as Interim Director in 2009 and 2010 and is now Associate Director. Grant Black (BS 1992, MA 1994) became Center Director in fall 2010.





The Center has become a leading source of training, resources, and information for educators, students, professionals, and the community. Since its beginning in 1978, the Center has trained thousands of teachers and impacted thousands of students, as well as reaching countless others throughout the region. It has produced numerous educational resources used across the nation. In 1988 the Center was recognized as one of the top five centers of economic education in the nation by CEE. In recognition of its ongoing innovative work, the Center received the Albert Beekhuis Award for Centers of Excellence in Economic Education from CEE in 2003. In 2012 a curriculum coauthored by Sharon Laux and published by CEE, Financial Fitness for Life®, Grades 9-12, won the Excellence in Financial Literacy Education (EIFLE) Award in the Education Program of the Year in the Children's Saving and Investing category.

With the Center now formally reunited with the Economics Department, great things are to come!

Faculty News

Susan Feigenbaum was awarded the title of Curators' Teaching Professor this spring. She is grateful for the many letters of support she received for her nomination.

Tom Ireland, Professor Emeritus, is continuing to consult for attorneys and has continued to publish papers in the area of forensic economics, the most recent of which was "A New Class of Hybrid-Tort Actions Based on Recent FELA Decisions?" in the *Journal of Legal Economics*, Volume 21 (1). He has two additional papers scheduled for future publication. He is also finding time to travel, with upcoming trips to Albuquerque, New Mexico, Portland, Oregon and Spokane, Washington.

Lea-Rachel Kosnik continued to publish, teach, and attend conferences this year. Perhaps even more importantly, she spent a good deal of time advocating for women's issues over the past year, helping to found and become the faculty advisor for the department's new Women In Economics (WIE) club. She also published a book (The Other Shakespeare) which asks the question: What if Shakespeare had been born a woman? What would her life have been like, and would she have been as successful as the William Shakespeare we all know today?

Don Kridel is currently interested in automating analytics and applying econometric techniques to real-time decision-making, especially as it applies to placement of mobile advertising and for fraud detection. Don's term as Chair of the Department ends in July 2015; he will continue to serve as Director of Graduate Studies for the department. During 2015, Don presented two papers in Hawaii (Maui and Kauai) related to model automation. On the personal side, Don visited Austin for his birthday this year; the Texas weather presented him the opportunity to drive back (13 hours!) to give his applied econometrics final. Don will be on sabbatical for 2016.

Sharon Levin, Professor Emeritus, is still getting grants and doing research. She is the PI on an NIH Grant titled 'Investigating the Scientific Workforce in the Biomedical and Behavioral Sciences. Also on the grant are Anne Winkler and Michael Allison.

William Rogers and Anne Winkler continue their research on the impact of housing and labor market conditions on household size and composition. Over the summer

they will add homelessness to the analysis as they team up with Patrick Fowler from Washington University.
